

POTENTIAL CONFLICTS OF INTERESTS OF ANALES DE PEDIATRÍA EDITORS

Corsino Rey Galán is head of the Pediatric Intensive Care Unit of Hospital Universitario Central de Asturias and professor of the university of Oviedo. He has received financial support from the companies Thermofisher / Brahms, Roche and Biomerieux to give lectures on diagnostic and prognostic biomarkers and from the company Alexion to give lectures and attend courses on diagnostic-therapeutic protocols in thrombotic microangiopathies.
